



ArchiveOne Enterprise (Policy) Version 6.0 Release Notes

Introduction

These release notes are for ArchiveOne Enterprise (Policy) Version 6.0 (build 2390). They detail the changes between this version and the previous (Version 5.8 SR2), how to install or upgrade to this version and the licensing / version assurance implications.

Installation

The product is supplied as a full standard installation package.

There are no specific requirements or changes to the normal install procedure. See the ArchiveOne Enterprise (Policy) documentation for details on installing.

In place upgrades can be conducted as long as the customer is running the 5.8 SR1 version of the component (Service, Websites, Quicklink Client, laptop Client or Admin Console)

Note: If you have deployed a prior version of the Quick Link, PST Processor or Laptop Client, it is necessary to deploy the 6.0 version of these components

Licensing / Version Assurance

This is a full release update and as such is only available to customers with a valid Software Version Assurance (SVA) contract.

Note: Customers without valid Version Assurance can contact their Account Manager to reinstate version Assurance and then upgrade to this version.

New Features

Full Support for Exchange 2010 SP1

Previous versions of ArchiveOne Enterprise (Policy) provided support for Exchange 2010. This version now supports all aspects of Exchange 2010 SP1, including split server role across multiple physical or virtual servers, Client Access Server (CAS) Arrays, Database Availability Groups (DAGs) and Load Balanced CAS Arrays.

New ArchiveOne Audit Service

Previous versions of ArchiveOne wrote audit data to CSV files; this new version has a completely re-architected, 'cradle to grave' auditing infrastructure with an optional SQL, SQL Express or CSV data storage back end.

All service actions are traceable and each stage of the archive process (identification, indexing, compression, stubbing) is audited along with other important 'changes' in the lifecycle of an item in the archive.

New WebAdmin Component

A new website is now available to carry out a number of operational and business tasks. This includes:

Dashboard – a web page providing 'at a glance' information and status on the ArchiveOne solution. This gives textual and visual graphic displays of the status of major ArchiveOne components, views of items being queued or dequeued for archiving and allows basic control over starting and stopping policies and services.

Audit Console – a web page providing search and report facilities for the new Auditing data. This provides a number of predefined filters and the ability to specify a date range.

Legal Console – a web page providing a simplified legal search/discovery interface for non IT business users. It allows simple (Google style) keyword searching as well as multi criteria advanced searching, with Boolean and proximity operators. Search results can be selected and provide a preview of the original item with search term syntax highlighting and the ability to put the items on (or take off) legal hold.

New Search Website

The AOneSearch, end user search website has been completely updated to provide a much better and more intuitive experience. Search results are sortable, filterable and search performance has been improved.



Central Configuration of Client Components

Configuration options for client options (Web Service URLs to use, tracing, retrieval method, folder names etc.) can now all be configured centrally, with defaults that all users get and the option to override individual users if necessary.

Deployment Analyzer

The new ArchiveOne Deployment Analyzer tool is now installed by default on every install. This allows the administrator to run suites of tests to ensure that they are following best practices, notify them of any potential issues and to help troubleshoot any problems they may have.

Enhancements

Progress Visibility Improvements for PST processing

There have been a number improvements around PST Processing to assist with understanding the progress of each individual PST as well as an overall view of the progress of all PSTs.

Outlook 64bit Support for Client Components

All client components (QuickLink, PST Processor, AOneManageForm and Laptop Client) have been updated to support the 64 bit version of Microsoft Outlook 2010.

All client components will automatically detect the 'bitness' of the Outlook version and work correctly, removing the need to install specific client version on specific user machines.

Archive Search Performance Improvements

The speed of searching the Archive Repositories has been considerably improved. Large searches are also split into multiple smaller searches allowing large searches to be cancelled part way through.

Text Extraction Improvements

The components that do text extraction have been moved out to a separate service allowing for better control over third party elements that may have memory leaks or other bugs (such as Adobe's PDF iFilter) and better control over 32/64 bit filter considerations.



Laptop (Sync) Client now works over HTTP

The laptop client can now get it's updated local repositories over HTTP instead of SMB file share access. This allows remote users to get updated local repositories without the need to VPN or come into the office.

Run 'Stage 2' for a selected Repository

It is now possible to right click on a Repository and select to run 'stage 2' processing for it. This removes the need, in certain circumstances, to wait for the 'hourly tick' to get any remaining data processed.

Improved granularity of messages for Stage 2 results

The textual results messages for stage 2 have been improved by making them more granular and providing the admin with a clearer indication of what is happening.

Enable or Disable end users for using PSTs

The PST Processor client now has two additional command line options - "disable_pst_use" and "enable_pst_use". These allow or disallow the use (creation) of PST files by the end user.

- **5926:** WebAdmin: The default setting of "ResultsCountLimit" in web.config is not high enough. Needs to be more than "GridLimit"
- **5927:** WebAdmin: When printing an item from the "Preview" widget, after the print window closes and the widget refreshes, the preview message body disappears until you click on something else.
- **5928:** WebAdmin: If Web Admin & Auditing are installed on a server that uses HTTPS, may have issues with getting the search criteria groups fo rhte audit search
- **5929:** WebAdmin: If web admin is installed on a server with HTTP, the value of "AOneAudit.Audit" in web.config seems to be set incorrectly
- **5930:** Upgrade: Upgrade of OEM version of Policy fails with Error 1723 - A dll cannot be run.
- **5931:** Upgrade: Different behaviour between OEM and Enterprise setups when performing an upgrade?
- **5933:** WebAdmin: "aoneadminsmall.jpg" is missing from archiveonewebadmin web site.
- **5934:** Cannot use Search & Retrieval website - error complaining that default.aspx is missing from the AoneSearch website install is in the trace files.
- **5935:** Upgrade of S&R Website doesn't complete fully --> Something isn't registered.
- **5936:** Upgrade: After upgrade, unable to log in straight away with the admin console --> saved server name appears to have a new line on the end of it
- **5937:** Upgrade: Upgrading Express, actually uninstalls it
- **5939:** After upgrading from 5.8.2 GA to 6.0.0 Admin console is unable to login
- **5940:** When I restart the service account, I get a report of an application crash in the windows event viewer
- **5943:** ArchiveOne PST Status report progress bar shows incorrect " So far PST data processed % "
- **5945:** Admin: If there are no discovered PSTs, the "View progress..." context menu item does absoltely nothing



- **5947:** Cannot sort data in the Grid in the PST status report by "Path".
- **5948:** Disallow the option to install SQL Express if we're installing on a DC
- **5973:** WebAdmin: Confirmation message about marking an item as deleted needs changing --> needs spelling correction and alteration to the same style as other messages
- **5974:** Auditing: When renaming policies from the context menu, the "root:admin:policy:modify:begin", "root:admin:policy:modify:endFailed", and "root:admin:policy:modify:endFailed" events are missing information
- **6002:** WebAdmin: Hiding and then Unhiding the "Archive Queue - Realtime", "Archive Queue - Activity" and "Archive Queue - Activity Charts" widgets adds an extra "Select Repository" section each time this sequence of actions is performed.
- **6004:** WebAdmin: The "Archive Queue - Activity" figures are incorrect -> then leads the Activity charts to be incorrect.
- **6005:** WebAdmin: The Search box on the Legal Console Page (for performing archive searches) becomes very small when you turn on compatibility mode in IE
- **6009:** WebAdmin: IE compatibility mode makes the drop downs in the Actions widget on the Dashboard page impossible to use effectively
- **6011:** MANUAL express quickstart prereq's wrong
- **6012:** Accessing browse Archive website from Outlook results in a script error
- **6013:** WebAdmin: Search words are not highlighted if they are in the TO, CC, BCC, FROM fields in the preview widget on the Legal Console page.
- **6014:** S&R Website: When viewing the search and retrieval website in Outlook, the "Search" box is very small
- **6015:** S&R Website: Get a script error when moving widget around when the S&R website is viewed in Outlook
- **6016:** BrowseArchive: Trying to retrieve an item from Browse Archive when Browse Archive is viewed in Outlook results in script error
- **6017:** BrowseArchive: Trying to retrieve an item from Browse Archive in a web browser results in an error occurring in the AOneSearch website.
- **6027:** Attempted item retrieve via the link in a message isn't opened in new web browser window --> S&R website doesn't look to be finding the item
- **6032:** Disabling attachment download from preview
- **6033:** WebAdmin: Preview pane doesn't always highlight words according to the phrase searched for
- **6040:** S & R Website: No Web service found
