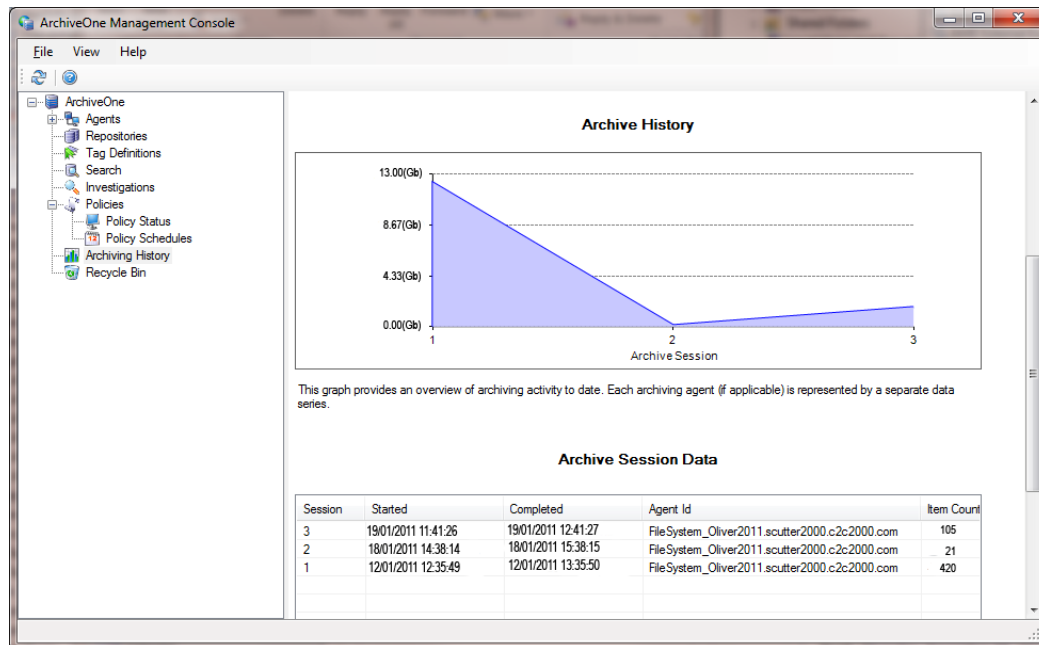


## Reduces backup windows
